PRESIDENTS MESSAGE....

The Board of Directors will have a proposed budget for the membership to review, discuss and vote for approval at the February 1 meeting. Overall, the 2024 end-of-year "Actual" versus "Budget" report looks pretty good, except for the Christmas Party. The total expenses were \$1,998.00, a significant \$998.00 over the budget of \$1,000.00. This was caused by multiple factors. First of all, it was discovered after the fact that the quote from Misty's did not include sales tax, tips, tax on tips and dessert totaling \$528.00.

And then, compounding that, the total cost for just the meals was actually \$1,470.00, which was \$470.00 more than the budgeted \$1,000.00. That \$470.00 over budget for the meals plus the \$528.00 unplanned expenses accounts for the total \$998.00. Sometimes the good intentions and deeds of volunteers do fall victim of thee ole saying, "No good deed goes unpunished"! We shall, though, remain grateful to those willing to give of their time to do the "greater good for the greater number"!

The Board had decided by majority vote, although not a unanimous vote, to subsidize the members' meals with \$20.00. There was a minority suggestion the subsidy should be \$10.00. That amount would have reduced the deficit by \$400.00, a no small amount. There was \$574.00 received from members, which was the meal cost over the \$20.00 subsidy per meal. (Chicken \$25, Salmon \$39, Steak \$41).

There is enough money in the Club treasury to absorb this loss, but, still, wasting this amount of money is improper as well as not sustainable. The costs at Misty's, or for that matter any other eatery offering banquet facilities, is no doubt going to continue to increase. So, more attention needs to be directed at controlling costs for the Club.

What do we do? A consideration is to hold the Christmas Party at the same location as our Chapter meetings and have a meal catered in. The date and other particulars would need to be worked out with the Church. The Model A Club, though, is already paying rent to the Church for a December meeting and not holding it.

Come to the February meeting and participate in this discussion.

Kimmel Orchard in Nebraska City is celebrating their 100th anniversary this year and has invited the Cornhusker Model A Club and the Meadowlark Model A Club to come and display our Model A's on April 26, 2025. The show would be from 10:00 am - 2:00 pm. Granted, the weather can be iffy that time of year. I have received confirmation that the Meadowlarks are planning on attending, so, is there interest in the Cornhusker Club members in going?

The 65 in 2025 Celebration Committee met with Speedway Motors Museum staff on January 14 and a decision was made to stage the Celebration on the grassy area north of the Museum. Now we need to provide a guesstimate of how much space we'll need. A flyer has been prepared and will be presented at the February meeting. It will soon start appearing on bulletin boards around town. **June 28** will be here plenty soon.


